### **Basic Information**

Accreditation Year: The official accreditation year of the district (or school in the case of DoDEA Virtual School). In the case of Europe West and DoDEA Virtual School, some accreditation activities were delayed until 2021 due to the pandemic, but retain their official accreditation year of 2020.

#### Staff by the Numbers

Number of Teachers: The number of teachers is based on the number of teaching positions in the school as recorded in DoDEA's Manpower Management Tool in early October annually. Positions were categorized as teaching positions by a cross-functional team of HR and Manpower staff based on job description in the DoDEA's Manpower Management Tool. Each teaching position is counted regardless of whether it was full or part time.

The Degrees of Teachers, Number of Military Spouses on Staff, Veterans on Staff and % of Teachers with 3+ Years at DoDEA metrics are all based on DCPDS data as of the end of April each year. The metrics reported for teachers only (Degrees of Teachers, the % of Teachers with 3+ Years at DoDEA) were categorized as teaching positions by a cross-functional team of HR and Manpower staff based on job description in the DoDEA's Manpower Management Tool. Each teaching position is counted regardless of whether it was full or part time. Note that because of the differences in timing of available historical data, the total numbers will not necessarily total the same number or total the same number as the "Number of Teachers" metric.

## Students by the Numbers

All student counts and demographics are based on students enrolled in DoDEA schools on the annual enrollment census date in early October annually as recorded in DoDEA's Student Information System. The following types of students recorded in DoDEA's Student Information System are excluded from all counts and percentages in this section:

- Child Find students
- Auxiliary students (typically home school students)
- Category 5 students (non-DoDEA students at AFNorth entered into DoDEA's Student Information System for administrative purposes only)

Metrics in this section include:

- Total Students: The total number of students enrolled in the school.
- Students by Grade Level: The number of students enrolled in each grade level. For an explanation of DoDEA's Preschool programs, please see the <u>Preschool</u> page.
- Students by Special Program
  - 504: The percentage of students with a Section 504 Education Plan in DoDEA's Student Information System. For more information, please see <u>DoDEA's Section 504 Accommodations</u> page.

## **Academic Information**

- School-level percentage participating in DoDEA Virtual School courses: The percentage of all students in the school (regardless of grade) who had an active enrollment in one or more DoDEA Virtual School courses in early April each year.
- Percentage of students in grades 6-8 participating in Accelerated Math: The percentage of students in grades 6-8 who had an active enrollment in an advanced math course in early April each year. Advanced math courses were defined by DoDEA's Secondary Math Curriculum Specialists to be Accelerated Math 7/8 and Accelerated Math 8/Algebra I.

- NAEP Information: National Assessment of Education Progress (NAEP) scores are based on the 2022 NAEP administration. For more information, please visit the NAEP website.
- PSAT Information: DoDEA and school participation rates and average scores reported are from DoDEA analyses of student-level results provided to DoDEA by the College Board in combination with enrollment data from DoDEA's Student Information System. National average PSAT scores were retrieved from the <u>SAT Suite Program Results</u> made available by the College Board.
- SAT: DoDEA and school participation rates and average scores reported are from DoDEA analyses of student-level results provided to DoDEA by the College Board in combination with enrollment data from DoDEA's Student Information System. National average SAT scores were retrieved from the <u>SAT Suite</u> <u>Program Results</u> made available by the College Board. Note that DoDEA made significant changes to our administration of the SAT in SY23-24, moving to SAT school day as a Summative assessment for all 11th graders. The metrics reported for SAT have also been updated as a result.
- ACT: DoDEA and school participation rates and average scores reported are from DoDEA analyses of student-level results provided to DoDEA by ACT in combination with enrollment data from DoDEA's Student Information System. National average ACT scores were retrieved from the <u>ACT National Profile</u> <u>Report</u>.
- AP: All AP metrics reported are from DoDEA analyses of student-level results provided to DoDEA by the College Board in combination with enrollment and graduation data from DoDEA's Student Information System.
  - Percent of students who took an AP exam: Percent of students enrolled in the school in grade levels 9-12 in May 2024 who took one or more AP exams in SY23-24.
  - Percent of Exams scoring 3 or above: Percent of SY23-24 exams taken by students enrolled in the school in grade levels 9-12 in May 2024 that were scored 3 or above by College Board.
  - Percent of Graduates who took an AP exam in high school: Percent of students who graduated from DoDEA in SY23-24 who took at least one AP exam during high school (including AP exams taken by the DoDEA graduate in other schools typically prior to attending a DoDEA school).
